



## **Portmarnock Sports and Leisure Club Membership Terms and Conditions**

### **Members of the club must comply with the rules set out below.**

- 1.** The management reserve the right to reject membership or renewal options; or cancel memberships at any time.
- 2.** The management reserve the right to require any member, guest or person to leave the premises at any time.
- 3.** Memberships not renewed by the expiry date shall be deemed cancelled, however, memberships paid by direct debit or RCP will be renewed automatically.
- 4.** In the event of a failed direct debit payment or RCP payment, memberships shall be suspended or cancelled until outstanding balance is paid.
- 5.** Membership is not transferable from person to person.
- 6.** The management may withdraw use of all or part of the facilities for various purposes including maintenance. Compensation will not be given for any such closures however additional time may be added to a membership to account for the closure, at the club's discretion.
- 7.** All members must produce their valid membership card on each occasion they wish to gain entry to the facilities.
- 8.** If any member wishes to terminate their membership before it will expire, no refund for time remaining will be made. All cancellations must be provided to the club in writing. An emailed receipt of this will be issued when the termination is complete.
- 9.** The management reserve the right to restrict the number of persons using the club at any one time due to health & safety regulations. The management also reserve the right to amend the opening times of the club should they deem it necessary.
- 10.** Any club memberships purchased online are subject to management review during which the membership application may be denied and any monies paid will be refunded.
- 11.** The management reserve the right to utilise the facilities for special events, classes or other activities it may deem desirable.
- 12.** Any memberships for children under the age of 16 years must be attached to an adult membership, to act as guardian/ contact. This guardian must be over the age of 18 years.
- 13.** Use of the Sauna is restricted to PSLC members only and such members must be aged 18 years or over.
- 14.** Children aged under 15 years are not permitted to use the Gym.
- 15.** Children aged between 15-16 years may use the gym on PAYG basis only.
- 16.**

All Gym users aged under 16 years must have a signed parental consent form to be permitted to use the Gym.

16. All Gym users aged under 16 years must complete their gym session and leave the gym area by 6.30pm.
17. All Children under 16 years must be accompanied by an adult in the Pool. All Children under the age of 12 years with valid PSLC Membership are permitted to use the pool unaccompanied.
18. One adult may only be responsible for three children in the pool under the age of 8 years in accordance with our admissions policy.
19. Memberships may only be suspended for medical reasons supported by a valid medical certificate at the discretion of the management.
20. Members or visitors cannot use the facilities under the influence of any alcohol or drugs. No smoking permitted in the building.
21. Medical clearance should be sought for members with any medical conditions that may restrict their exertion levels prior to taking part in any exercise in the club.
22. Any member ignoring advice to seek medical advice or not seeking medical advice when instructed to by PSLC staff regarding a medical condition, may not hold the management responsible for any harm which may occur.
23. Appropriate clothing and footwear should be worn when using the various facilities.
24. Equipment should be returned to its correct location/position after use.
25. The club accepts no liability for accident or injury caused by any persons whilst using the facilities. Nor does the club accept responsibility for loss or damage to goods or valuables belonging to any member or guest.
26. Personal belongings may not be left in the lockers/locker rooms overnight. Items left behind/found will be donated to various charities or dumped periodically.
27. The management reserves the right to amend, add or alter these conditions of membership and club rules as it sees fit, and members should observe any amended or additional conditions or rules so made.
28. Any complaints concerning the club or dispute or difference about the interpretation of these conditions of membership and club rules, shall be referred to the management of the club. This decision shall be final and binding.
29. The club's general opening times are 6am to 10pm on Monday through Tuesday, until 11:30pm Wednesday through Friday and 9am to 11:30pm on Saturday & Sunday. Bank Holiday opening hours are from 10am to 4pm but these are subject to change.

### **Membership Cancellations**

While we will be sad to see any member leave us, we understand that certain circumstances occur and you may need to end your membership (hopefully short term) with us, we ask that members terminate their memberships at reception by signing a termination form.

**RCP Memberships:** We require at least one months' notice which needs to be in person by signing a cancellation form or via email.

**Monthly and Annual Memberships:** You are free to cancel your membership at any point with us, but as it is a fixed term payment we will not be offering a refund/credit back. This can be done in person or via email.
