We are holding an **EGM** (Extraordinary General Meeting) of the Club on Thursday the 19<sup>th</sup> of June at 8pm. To update members on some positive news: As you will remember at the AGM in 2024, the members approved the Committee to move the business and organisation from **Portmarnock Sports and Leisure Club** to **Portmarnock Sports and Leisure Club CLG** (company with limited guarantee) which gives the '**Club**' in its new status more opportunities for grants and drives a higher standard of governance under the Companies Act 2014

**The Good News** is that over the past year a lot of work has been done behind the scenes to get us to this point. The financial and legal pieces have been completed, we are registered and recognised as a CLG and will begin trading from the 1st of July 2025.



You will also be aware our members requested that we examine the whole membership structure, and to come up with a new structure, with pricing and benefits for members, that is fit for purpose, will generate new members and ensure the future of the club.

We have been working on this, talking with members, groups and clubs within the **PSLC**. We are now ready to share the new structure at the EGM.

**If you are a Founder, Lifetime or currently on a Ten-Year membership there will be no change to your status or membership, although** you may have noticed the Capitation payment is closed on the system at the moment, this will be up running again from the 1st of July, both online and at reception. We will also take the opportunity to propose a modest increase in the Capitation fee as this hasn't been increased in 5 years and costs are only going one way.

It is often very difficult to get a quorum for an AGM let alone an EGM, but we would ask you to spare some of your time so as we can move the **PSLC** onwards and upwards.
